The letter should be printed on company letterhead stationery, addressed to "The Consulate of Bangladesh, Visa Section", and signed by a senior manager (an equivalent to Vice-President or above). The business letter must adhere to the following guidelines: Briefly introduce the

applicant (please specify employment status/position held in the company by applicant). State the nature of the business to be conducted (ie. business meetings, contract negotiations, etc.) and the names and addresses of companies to be contacted in Bangladesh. ? Specify the type and desired validity of the visa (ie. a one year multiple entry business visa).

• Investor visa: Letter of recommendation from Bangladesh Ministry of Industries or Board of Investment (BOI) or Bangladesh Export Processing Zones Authority (BEPZA).
