- Letter of Invitation. An official letter of invitation approved by the Ministry of Foreign Affairs in Turkmenistan.
- Persons with dual citizenship, one of which is US, must apply with their US passports only.
 Applicants with other than US passports must provide the copy of the document confirming their current resident status in USA

The business letter must adhere to the following guidelines: Briefly introduce the applicant (please specify employment status/position held in the company by applicant).
